Povzetek:

Teoretsko področje preprečevanja oboroženih konfliktov še ni ustrezno odgovorilo, na kak način naj mednarodne organizacije pristopijo k preprečevanju konflikta v določenem konfliktnem okolju (kakšne pristope, strategije in sredstva uporabiti) in kako tovrstno delovanje mednarodnih organizacij percipira lokalno prebivalstvo. Raziskava delno zapolnjuje to vrzel; fokusira se na vlogo štirih mednarodnih organizacij (OZN, OVSE, EU in NATO) na Kosovu med letoma 1999 in 2008. Raziskovalna metodologija je temeljila na vzajemnem prepletanju kvalitativne in kvantitativne analize: analiza primarnih in sekundarnih virov, zgodovinska analiza, anketiranje na terenu in intervjuvanje. Izvedenih je bilo 123 anket in 33 polstrukturiranih intervjujev. V ADP so dostopni le podatki zbrani z anketo.

Vprašalnik je v izpolnjevanje prejelo vseh 120 poslancev skupščine Kosova: 100 poslancev albanske narodnosti, 13 poslancev srbske narodnosti in 7 poslancev drugih manjšin. V primeru lokalnih prebivalcev je bil vprašalnik naključno razdeljen med prebivalce krajev Leposavič (120), Ajvalija (90) in Gračanica (90). Kraji so bili izbrani iz dveh razlogov, t.j. zaradi specifičnosti etične strukture prebivalstva in geografske lege (več informacij je na voljo v doktorskem delu).

Anketni vprašalnik poleg vprašanj zaprtega tipa vsebuje tudi nekaj odprtih vprašanj. V delu, ki zajema naloge posamezne organizacije, je bil vprašalnik oblikovan s pomočjo predstavnikov organizacij OZN, EU, OVSE in NATA. Slednji so pomagali oceniti, katere naloge v okviru preprečevanja oboroženih konfliktov določene z mandatom so bile najznačilnejše in najpomembnejše za njihovo organizacijo v obdobju od 1999-2008. Vprašalnik je bil primarno oblikovan v angleškem jeziku ter nato preveden v albanski in srbski jezik.

Opis zbiranja podatkov:

Točen datum zbiranja podatkov ni znan. Vsi podatki so bili zbrani v okviru enomesečnega terenskega dela na Kosovu.

1) Primarno je avtor poslancem v kosovski skupščini preko elektronske pošte poslal vabilo za sodelovanje z vprašalnikom v prilogi. Ker pa je bila odzivnost slaba (vrnjenih le 5 vprašalnikov), je v času bivanja v Prištini za pomoč pri razdeljevanju vprašalnika med poslance prosil 4 asistentke oz. asistente političnih strank v skupščini Kosova in predavatelja mednarodnih odnosov na Univerzi v Prištini. Izpolnjene in nepodpisane vprašalnike so poslanci vrnili asistentom svojih političnih strank, ti pa so jih posredovali avtorju ob koncu njegovega raziskovanja na Kosovu. 2) Ankete so bile lokalnemu prebivalstvu v treh krajih (pretežno albansko Ajvalia, pretežno srbsko Leposavič in Gračanica) s strani avtorja razdeljene naključno, po metodi 'od hiše do hiše'. Vsako gospodinjstvo je prejelo en anketni vprašalnik. V kolikor je bila oseba doma, je bila naprošena za sodelovanje, pri čemer je avtor bodisi sam izvedel anketiranje ali pa je oseba sama izpolnila vprašalnik in ga v kuverti poslala na (začasni) naslov avtorja v Prištini. V kolikor ni bilo nikogar doma je avtor v nabiralniku pustil vprašalnik s kuverto in znamko. Pri anketiranju v kraju Ajvalia je z avtorjem sodelovala študentka ekonomije na Univerzi v Prištini Medina Orana, v kraju Leposavič magistrski študent mednarodnih odnosov na Univerzi Cambridge, Branislav Nešović, v kraju Gračanica je anketiranje opravil avtor sam.

Ukrep za zmanjševanje manjkajočih podatkov:

Poslanci so 7 dni po prejetju vprašalnika na papirju, prejeli opomnik in prošnjo za izpolnitev oz. zahvalo preko elektronske pošte. Ker je bil odziv po prvem opomniku nezadovoljiv, so poslanci preko elektronske pošte prejeli dodaten opomnik in prošnjo za sodelovanje teden dni kasneje.

Stopnja sodelovanja:

Od 120 posredovanih vprašalnikov poslancem skupščine Kosova je bilo izpolnjenih 34 vprašalnikov, kar predstavlja 28,3 % stopnjo odgovora. Od 100 poslancev albanske narodnosti je vprašalnik izpolnilo 26 poslancev (26 %), od 13 poslancev srbske narodnosti 8 (61,5 %), medtem ko od 7 poslancev, ki zastopajo interese drugih manjšin ni bil izpolnjen noben vprašalnik. Pri lokalnem prebivalstvu je bilo izpolnjenih 89 vprašalnikov, kar pri 300 posredovanih vprašalnikih predstavlja 29,6 %. Prebivalci kraja Leposavić so izpolnili 23 vprašalnikov, kar pri 120 posredovanih vprašalnikih predstavlja 19,2 %, prebivalci kraja Ajvalija, ki so prejeli 90 vprašalnikov so izpolnili 39 vprašalnikov (43,3 %) ter prebivalci enklave Gračanica 27 (30 %) ob prav tako prejetih 90 vprašalnikih.
